

## **IMPORTANT TAX NOTICE RE: 2023 PFIC STATUS**

### **U.S. PFIC Information for U.S. Shareholders of Southern Silver Exploration Corp.**

This statement applies to Southern Silver Exploration Corp. and each of its subsidiaries listed in the Annual Information Statement below (collectively "Southern") and is provided for shareholders who are U.S. persons for purposes of the U.S. Internal Revenue Code ("IRC") of 1986, as amended and the regulations thereunder. It is not relevant to other shareholders.

Southern expects to be classified as a Passive Foreign Investment Company ("PFIC") as defined in Section 1297 (a) of the IRC for the fiscal year ended April 30, 2023, expects that it was a PFIC for all prior fiscal years and expects that it may also be a PFIC in subsequent years. Southern is hereby making available a PFIC Annual Information Statement for the fiscal year ended April 30, 2023 pursuant to Treasury Regulations 1.1295-1(g)(1).

The PFIC Annual Information Statement contains information to enable you, should you so choose based on the advice of your tax advisors in light of your personal tax circumstances, to elect to treat your investment in Southern as a Qualified Electing Fund ("QEF").

A U.S. shareholder who makes a QEF election is required to annually include in his or her income his or her pro rata share of the ordinary earnings and net capital gains, whether or not any amount has been distributed to shareholders. If you do not elect to treat your investment as a QEF, then if Southern is a PFIC for any year during your holding period, adverse tax consequences could result.

The QEF election is generally made on Form 8621 ("Return by a Shareholder of a Passive Foreign Investment Company or Qualified Electing Fund") on or before the due date, including extensions, for the income tax return with respect to the tax year to which the election relates.

To ensure compliance with Treasury Department Circular 230, you are hereby notified that anything contained in this notice concerning any U.S. federal tax issues is not intended or written to be used, and it cannot be used by a U.S. holder, for the purpose of (i) avoiding federal tax penalties that may be imposed on the taxpayer or (ii) promoting, marketing or recommending to any party any matters addressed herein.

This information is provided in order to assist shareholders in making calculations and does not constitute tax advice. The U.S. tax laws regarding PFICs are extremely complex and shareholders are advised to consult their own tax adviser concerning the overall tax consequences of their respective investment in, and ownership of shares of, Southern under U.S. Federal, State, Local and Foreign law.
